### **Introducing Summit and Summit Plus Plans to the Premier Network**

Effective 01/01/2018, EMI Health will introduce two new dental plans: Summit and Summit Plus. These plans will access the Premier Network in Utah and the Cigna Dental Networks outside of Utah. The ID cards will include both the EMI Health and Cigna logos. Utah dentists should continue to submit claims directly to EMI Health. Benefit plan designs mirror Premier, and claims will be paid according to the Premier fee schedule. The only difference between the Premier and Summit Plans is the out-of-Utah network.
